2012 Fall Symposium: Even Small Acts Make a Big Difference

Our Fall Symposium this year will explore the role of the individual in philanthropy - how regular people with passion and generosity can change the communities in which they live. We will examine how those of us who are not Warren Buffet, Bill Gates, and Oprah Winfrey and have never won the lottery, can change the world; how regular people with heart and humanity are changing lives forever -and how even small acts make a difference.

Our keynote speaker, Kathy LeMay, began her generosity journey in war-torn Yugoslavia where she worked with women survivors of the rape-genocide camps. Her personal motto is "do what you can, with what you have, from where you are." LeMay is the president and CEO of Raising Change, which helps groups raise capital to advance social change agendas and helps individuals create "Generosity Plans." LeMay has been a fundraiser for 15 years, raising more than \$150 million dollars in the fields of women's human rights, hunger and poverty relief. *(continued on page ?)*

At our Annual Meeting on May 15, we announced grants totaling over \$164,000 to help fund great community projects. In addition she has directed an additional \$100 million in philanthropic dollars to organizations working to make a difference. LeMay serves as an adviser and consultant to Fortune 100 companies, universities, international NGOs, and the United Nations..

In the year 2000, LeMay was nominated for a Reebok Human Rights Award for her 15 years of service as a human rights activist. She was just named one of Business West Magazine's "40 Under 40" and, in January 2010, released her first book, *The Generosity Plan, Sharing Your Time Treasure and Talent to Shape the World*. LeMay has appeared on numerous television and radio shows including Oxygen TV and The Oprah Show. She is a contributing columnist to *World Pulse Magazine*, where she also serves as chairman of the International Advisory Board. Having turned her passion for giving into a life mission, LeMay's message of universal philanthropy and the power of women to become change agents for social betterment is relevant, inspiring, and remarkably engaging. Her presentation style is genuine, insightful, and compassionate.

"Philanthropy is a muscle you flex. If you practice it all along throughout your life, it grows stronger" she said. "Even small acts of generosity can make a difference, if they are meaningful, significant and heartfelt".

Pam Parker Will Be Missed

Pam Parker, an eleven-year member of IWCF and leader in the Boise philanthropic and professional community, died on March 12 after a six year battle with ovarian cancer. As with all challenges, Pam faced her cancer journey with admirable tenacity and managed to support others dealing with cancer. Pam was an amazing mother, wife, friend, mentor and role model for professional women in Boise and she set the bar for community involvement.

Pam started her long career at the Boise YMCA in 1972 as a bookkeeper in the male dominated business arena that was Boise in the 1970s. She went on to become the director of philanthropy and communications at the YMCA in 2003 and was directly responsible for the building of the \$13.5 million West YMCA facility. She went on to be director of Philanthropy at the Nature Conservancy and the VP of Development at Bogus Basin.

Finally, she has inspired and encouraged others to be more involved in creating a cancer community in Boise to serve everyone who has been touched by cancer. Even at the end of her life she was more than willing to encourage other women's dreams and contribute to the betterment of our community.

She blazed the trail professionally and philanthropically. Her loss "leaves a huge hole" not only in the hearts of her friends and family, but in the heart of the Boise community that she did so much to enhance.
